THE GROUP BEGAN MEETING DURING THEIR LUNCH HOUR TO ORGANIZE FOOD SALES AND OTHER SMALL FUNDRAISERS TO RAISE MONEY TO HELP THEIR CLIENTS MEET THESE NEEDS. VIRTUALLY ALL OF THE MONEY RAISED BY ANOTHER WAY GOES DIRECTLY TO HELP CLIENTS.
