SUBJECT: DEPARTMENT DIRECTIVE 01-062220: CRIMINAL BACKGROUND

CHECKS FOR SELF-DETERMINATION PROGRAM AND FAMILY HOME

**AGENCIES** 

Individuals providing services to participants in the Self-Determination Program (SDP), as specified in Welfare and Institutions (W&I) Code section 4685.8(w), and Family Home Agency (FHA) applicants and adults providing services or residing in FHA homes, as specified in W&I Code section 4689.2, are required to obtain fingerprint-based criminal background checks.

The Department of Developmental Services recognizes that due to the COVID-19 crisis, there is a shortage of available fingerprinting services, which impacts the ability of individuals to complete the required criminal background checks. Therefore, pursuant to Governor Gavin Newsom's Executive Order N-68-20 issued on June 5, 2020, to the extent W&I Code sections 4685.8(w) and 4689.2 require use of an individual's fingerprints to obtain a criminal background check or clearance, the fingerprinting requirement is suspended through July 31, 2020. As stated in Executive Order N-68-20, the California Department of Justice is excused from requiring fingerprints to conduct criminal background checks through July 31, 2020. While submission of fingerprints is not required for individuals specified in W&I Code sections 4685.8(w) and 4689.2 through July 31, 2020, a criminal background clearance is required. Unless an intervening Executive Order is issued, individuals are required to obtain criminal background checks utilizing fingerprints beginning August 1, 2020.

Applicants are encouraged to seek fingerprint-based background checks where access to Live Scan is currently available to them. If Live Scan is not available and a background check is needed before August 1, 2020, enclosed is the California Department of Justice Form BCIA 9010-COVID-19 that must be completed by any person seeking to obtain a name-based criminal background check for purposes of W&I Code sections 4685.8(w) and 4689.2.
