#### FY 2023-2024 Project #1: Crisis Training Services

**GEOGRAPHIC LOCATION**: Riverside County

CONTRACT AWARD AMOUNT: Startup funding UP TO \$400,000

**SERVICE DESCRIPTION:** IRC seeks the development of a community-based Crisis Support Service in Riverside County. Start-up funds will be used to bring a Crisis Service Provider that meets the requirements of ABA services to provide on demand support to individuals who are experiencing aa behavioral crisis. Services provided will focus on IRC eligible individuals, who have one or more of the following characteristics/diagnoses: Autism Spectrum Disorder (ASD), Dual Diagnosis with Mental Illness, behavioral needs requiring ABA interventions, and/or are part of the Deaf and Hard of Hearing (DD/H) and Deaf Plus population. The Crisis Service Provider will partner with the Inland Empire Autism Society to provide training to the Riverside and Corona Police Departments, creating standardized training for responding to a crisis involving an IRC consumer. The applicant must have experience providing ABA/Crisis intervention services to individuals with developmental disabilities.

Applicants/Entity submitting proposal must have the following qualifications:

- This proposal is open to all service providers, however current IRC vendors familiar with Crisis Support Services are encouraged to apply.
- The service provider must have a certified BCBA to oversee services provided, proof of BCBA certification required.
- Staff providing direct services, must meet one or more of the following qualifications: Certified Assistant BCBA (ABCBA), and/or Certified Registered Behavior Technician (RBT).
- Staff who are fluent in ASL and Tactile ASL preferred.

- Staff fluent in ASL and/or one year experience in working with persons with Intellectual and Developmental Disabilities.
- Any Current Regional Center Vendored Service Providers:

Current vendorization(s) must be in compliance with proper insurance(s), business

 licenses and other professional licenses pertaining to vendorization or repayment of any funds.

Current vendorization(s) must not be on a Plan of Correction, Corrective Action Plan or have any substantiated Health and Safety risks that have been identified by assigned QA
